Initially Dai Mission Ministries began as a collection of believers from various faiths to discover the truth behind the Scriptures, a quest pursued to this day, with emphasis on the true meaning and intent of the original source writings of the Torah, the Tanakh, the New Covenant Scriptures, and Apocryphal texts. Through working with other seminaries and yeshivas it is the intention of the Ministries to establish its own yeshiva in the future, recognized by its seminary partners, to train and later ordain ministers in the various forms of the Messianic Jewish faith. This yeshiva will be the cornerstone of the kibbutz of Goshen, CO which is meant to be the end road project of the various Messianic Unions established.

Through the Messianic Unions throughout the western states, Dai Mission Ministries seeks to bring unity amongst the various congregations, small groups, and evangelistic ministries of the Messianic and Hebraic Roots faith and host local area conferences upon the monthly or quarterly Erev Shabbat or Shabbat gatherings chosen by the Elder over your local Messianic Union. Services are open to all to provide an avenue for fellowship and provide a venue for future believers interested in becoming more familiar with the Messianic path of faith. These conference services typically open with an oneg meal, followed by corporate prayers, music worship, dance, and finish with either an accomplished speaker or an open Midrash. For Feast Holidays, Dai Mission Ministries hosts organizational level services for the feasts of Pesach (Passover), Shavuot (Pentecost), and Sukkot (Tabernacles). For the other Hebraic holidays the local Unions work with local congregations to organize intercongregational celebrations.

Messianic Union Membership Dues

For the year of 2020 the Dai Mission Ministries Council of Elders (Board of Directors) with the approval of our President has set this year’s annual membership dues fee for congregations to be \$500.00 per congregation or organized ministry whose gross receipts are at or under \$50,000 for fiscal year 2019.

For congregations and ministries whose gross receipts surpass \$50,000 for fiscal year 2019, the annual membership dues fee will be 1% of the gross receipts of the organization for year 2019.

Your membership dues will be applied to the forwarding unity in the faith and helping your local Union provide for its local conferences and outreach services to others in need within your local community area and promotion of mutual ministerial events. If you would be interested in having an available Teaching Deacon or your Union Elder provide a drash and teaching presentation at your congregation as a special guest please contact your Union Elder to schedule such for the arrangements.

Arrangement of as afternoon community meal or oneg as part of such speaking engagements is customary and recommended to increase the draw of such speaking events and create a more memorable experience for your congregational membership. Any additional monetary offerings as love offerings by your congregational members and attendees would be welcomed, appreciated, and recognized by Dai Mission Ministries as a fellow partner in our cause for unity and our outreach mission.

Membership dues fees may be paid for the year either at the time of application or by pledge to pay any outstanding dues by March 31<sup>st</sup>, 2020. After March 31<sup>st</sup>, 2020 the membership dues must be paid at the time of the application to ensure proper accounting of eligible members for organizational voting rights.
